

Website Privacy Policy

1. Introduction

2. Information Collection and Use

2.1 Personal Information

The Company takes reasonable measures to protect Users' personal information from unauthorized access, alteration, disclosure, or destruction. However, no method of transmission over the internet or electronic storage is 100% secure, and the Company cannot guarantee absolute security.
